Subject: URGENT!!!

Assemblyman Roger Green has scheduled Assembly Bill A1123 to be put to a vote before the Assembly Children and Families Committee next Tue., 11 May. A1123 would establish that, absent a showing of parental unfitness or potential harm, a rebuttable presumption of shared parenting is in the best interest of children following separation and/or divorce of their parents.

This vote has been called on very short notice, and therefore precludes any ability to mount an organized showing of support via regular mail (we have only the weekend and Monday the 10th to mount this effort). It is CRITICAL (!), nevertheless that the members of this committee hear from each and every one of us via telephone.

The contact list (ONLY 16 NAMES) below is provided to facilitate that. Please BEGIN NOW (!) to call each of the elected reps. on this list, and simply provide your name (they may ask for a telephone number and/or address), where you're calling from, that you support this bill (A1123), and that you would like to request the representative's vote in favor of it when it comes up next Tue. It's that simple.

Call both their Albany and their District Offices, and do not hesitate to call over the weekend; simply leave your name, phone number, and request for a "yes" vote (please note that E-MAIL WILL BE VIRTUALLY USELESS, as e-mails recently are not being efficiently forwarded to the representatives, are simply being ignored, and/or are being blocked altogether).

We can get this thing out of committee, but success or failure depends on YOU. If you can't do something as simple as making 32 telephone calls (two each per rep.), or certainly 16, then you have no grounds for continuing to condemn the current Family Court system and the way you've been or are being treated. PICK UP THE PHONE, AND START CALLING NOW!!!
